#### **FIRST - ORGANIZING ENTITY**

## SECOND - IDENTIFICATION OF THE CONTEST AND DATE OF HOLDING THE CONTEST

Clinical Cases DDIs (<a href="www.clinicalcasesddis.com">www.clinicalcasesddis.com</a>) is an open-access tool to share and look for real-life experiences of clinical management of DDIs among all professionals involved in the provision of HIV healthcare. This random drawing is open to anyone who submits an eligible case within the indicated timeframe w a

The selected person will have at their disposal up to 1.500€ dedicated to their attendance to a congress. The type of congresses or meetings eligible to be chosen to participate in scientific meetings related to pharmacy, infectious diseases, or HIV.

Starting date: February 24, 2025

Last day to submit cases: December 31, 2025

Date of publication of results: January 31, 2026

#### THIRD - OBJECT OF THE CONTEST

The objective of the contest is to provide the winner with a prize of up to 1.500€ to attend the congress of their choice in 2026. The amount awarded will be used for covering expenses such as registration, flights and hotels. The management of the amount will be the responsibility of the Foundation. If the winner does not spend all the amount awarded, in no case, they will receive the difference. If the user spends more money, the difference will be billed separately.

#### **FOURTH - PROCEDURE**

# 1. Inscription and participation requirements

Any person of legal age who has submitted a case within the indicated period. Users must access the website (<a href="www.clinicalcasesddis.com">www.clinicalcasesddis.com</a>) and report a case in the section "Report a case". Before reporting the case, they must have a registered user on the platform. Users can report cases about real experiences on the clinical management of drug interactions in HIV patients.



#### 2. Awards

The selected person will be notified by email (at the address indicated when a case is reported) on the 31st of January 2026.

The selected person will have at their disposal up to 1.500€ dedicated to their attendance to a congress. FUNDACIÓN FLS DE LUCHA CONTRA EL SIDA, LAS ENFERMEDADES INFECCIOSAS Y LA PROMOCIÓN DE LA SALUD Y LA CIENCIA will be the technical secretary who will oversee the payment of registration, flights, and hotels. Therefore, the selected person will not receive the money, instead the technical secretary will manage it. This fee is up to 1.500€, but if the user does not spend the whole amount, in no case they will be paid the difference. If the user spends more money, then the difference will be billed separately.

# 3. Form of presentation of the projects

In order to report a case, participants will need to complete the form and the information requested in the "Report a case" section of the website (clinicalcasesddis.com/ddis/report/).

# 4. Content of the projects

Once reported, the case will follow the normal project review process. Currently, two reviewers made up of randomly selected members of the editorial committee oversee reviewing the case and assessing whether it is suitable for publication on the web or whether modifications need to be made, which are requested directly to the person reporting the case. Once the necessary modifications have been made and the reviewers consider that the case is suitable for publication, it will be published on the web, visible to anyone who wants to consult it. Only those cases that have been accepted by the reviewers and that, therefore, are already public on the web will participate. Those cases that are not eligible and, therefore, are not public on the web, will not be able to participate in the contest.

# 5. Evaluation and assessment criteria

The selection of the winner will be made randomly through an online drawing system. The names of the participants in the draw will be entered and the website itself will randomly select the winner.

## 6. Communication and publication of the prize

The winner will be notified by email to the address indicated when a case is reported, on the 31st of January 2026.
